The uMgungundlovu District Municipality (uMDM) hereby requests lease proposals for at least 300 m<sup>2</sup> gross of suitable office space, preferably within 1 km radius within the Central Business District of Mkhambathini for a period of 6 months with an option to renew for a further 6 months.

DISTRICT MUNICIPALITY (Mkhambathini) AS FOLLOWS:**

- 3x offices for Technical Ops Team
- 1 x Boardroom/ lecture room
- 2 x rest rooms - male and female
- 2 x Bath rooms (both must have showers) - male and female
- 1 x gym area 5 x 5m<sup>2</sup>
- 1 x lecture/Lounge/Liesure room
- 1 x by fitted kitchen with stove
- 1 x W/C - duty office
- 1 x S/O office ( bath room - shower)
- 1 x laundry area to wash and disinfect fire kits
- 1 x Storeroom

Only quotations placed in the Tender Box shall be accepted.

The Evaluation and Adjudication of the quotations will be done in line with the uMgungundlovu District Municipality's approved Supply Chain and Preferential Procurement Policies on an 80/20 system. The allocation of points will be in line with B-BBEE as prescribed in terms of the Preferential Procurement Regulations 2017, pertaining to the Preferential Procurement Policy Framework Act, Act No.5 of 2000. **Tenderers are required to be registered onto the Central Supplier Database (CSD). A valid SANAS accredited original or certified B-BBEE status level verification certification or affidavit must be submitted in order to claim preference points. Company registration documents must also be provided.**

Please ensure that the following necessary documentation are attached, i.e.

1. Valid original tax clearance certificate or Tax compliance status pin;
2. Proof of registration with the central supplier database (CSD);
3. Statement of account for the business premises indicating that no municipal service charges are in arrears for longer than 90 days OR in the case where the business premises are leased then a letter from the landlord indicating that no levies are outstanding together with a copy of the lease agreement. Statements or letters from the landlord must not be older than three months from close of advert;
4. MBD 4 – Declaration of Interest;
5. MBD 8 – Declaration of bidders past SCM practices; and
6. MBD 9 – Independent Bid Determination.
