uMgungundlovu District Municipality Fire Services By-law — To regulate and provide for procedures, methods and practices to regulate fire safety within the area of jurisdiction of the uMgungundlovu District Municipality and any matters connected therewith.

uMgungundlovu District Municipality Draft Air Quality Management By-laws — for regulation of sustainable implementation of air quality standards within the area of jurisdiction of the uMgungundlovu District Municipality

uMgungundlovu Environmental Health By-law- to regulate , in conjunction with any other applicable law, a legal framework for all activities that have the potential to impact adversely on health
